## Terms and Conditions for Co-option of Professional Directors

a) The Punjab Cooperative Societies Act, 1961 under Section 26(a) 4 and Bye-Law no. 30(vi) as mentioned as below: - The Punjab Cooperative Societies Act, 1961 under Section 26(a) 4 states that:- "Notwithstanding anything contained in sub-section (1), the committee shall co-opt as members from amongst the persons having an experience in the field of banking, management and finance or having specialization in any field relating to objects and activities undertaken by such a society: Provided that the number of such co-opted members of committee shall not exceed two in addition to nine members specified in the first proviso to sub-section (1) of section 26:

Provided further that such co-opted members shall not have the right to vote in any election of the cooperative society in their capacity as such member and shall also not to be eligible to be elected as office bearers of the committee."

And as per Bye-laws no. 30 (vi) of The Bathinda Central Cooperative Bank Ltd, Bathinda, two Professional Directors are required to be co-opted as Director on the Board of Directors of the Bank. Provision is as follows:

(a) "Two persons may be co-opted as professional Directors by the Board of Directors out of a panel approved by the Registrar, Cooperative Societies, Punjab consisting of persons having experience in the field of Banking, Financing Agriculture Economics or Management."

(b) "Such Co-opted members shall not have the right to vote in any election of the bank in their capacity as such members and shall also not to be eligible to be elected as office bearers of the Board

There shall be at least two directors on the Board with suitable banking experience (at middle/senior management level) or relevant professional qualification, that is in areas of: -

- i) Accountancy
- ii) Banking
- iii) Agriculture and Development
- iv) Legal
- v) Auditing etc.

The Directors of Cooperative Banks must be knowledgeable and persons of high integrity. They must function in a cohesive manner and provide leadership for the smooth and efficient management of the affairs of the bank.

c) Further the qualifications specified in RBI Circular No. RPCD.CO.RCBD.137/03.01.03/2011-12 dated 05-07-2011 regarding The Fit and Proper Criteria for appointment of Directors and CEOs of DCCBs are as under:

1. Minimum five years of work experience in any of the following fields:
  - i) Accountancy (Qualified Chartered/Cost Accountant)
  - ii) Agriculture (Agriculture Graduate/ Post-graduate/Agriculture Engineer)
  - iii) Banking (At Senior Management Level, being a graduate)
  - iv) Finance/Economics/Commerce/Business Administration (CFA/Postgraduate in Economics/Commerce/Finance/Management/MBA)
  - v) Law (Law graduate/Post-graduate)
2. Any person who has had a business relationship with the bank in question during the last 3 preceding years will not be eligible. A person having commercial dealing with the bank (viz, contractor, professional like legal advisor, auditor etc.) will be treated as having business relationship with the bank. A person having deposits with/borrowing from the bank will not be classified as business relationship for the purpose.
3. The Co-opted Director will undertake that he/she will not take up any Professional work (Statutory Audit, Concurrent Audit, Legal relationship, or empanelment as a lawyer, etc.) in the same bank during his/her term as Director of the Bank and till 2 years after demitting office of the director of the bank.
- d) No remuneration will be paid to Co-opted Professional Directors except sitting fees and TA/DA as admissible to other directors.
- e) Last date of receipt of application is **21-08-2026** up to 5.00 P.M.
- f) A declaration as in Annex-I shall be obtained from a co-opted director at the time of his/her appointment as per Bye-laws of the bank.
- g) Bank is authorized to reject any application without assigning any reason thereof.
